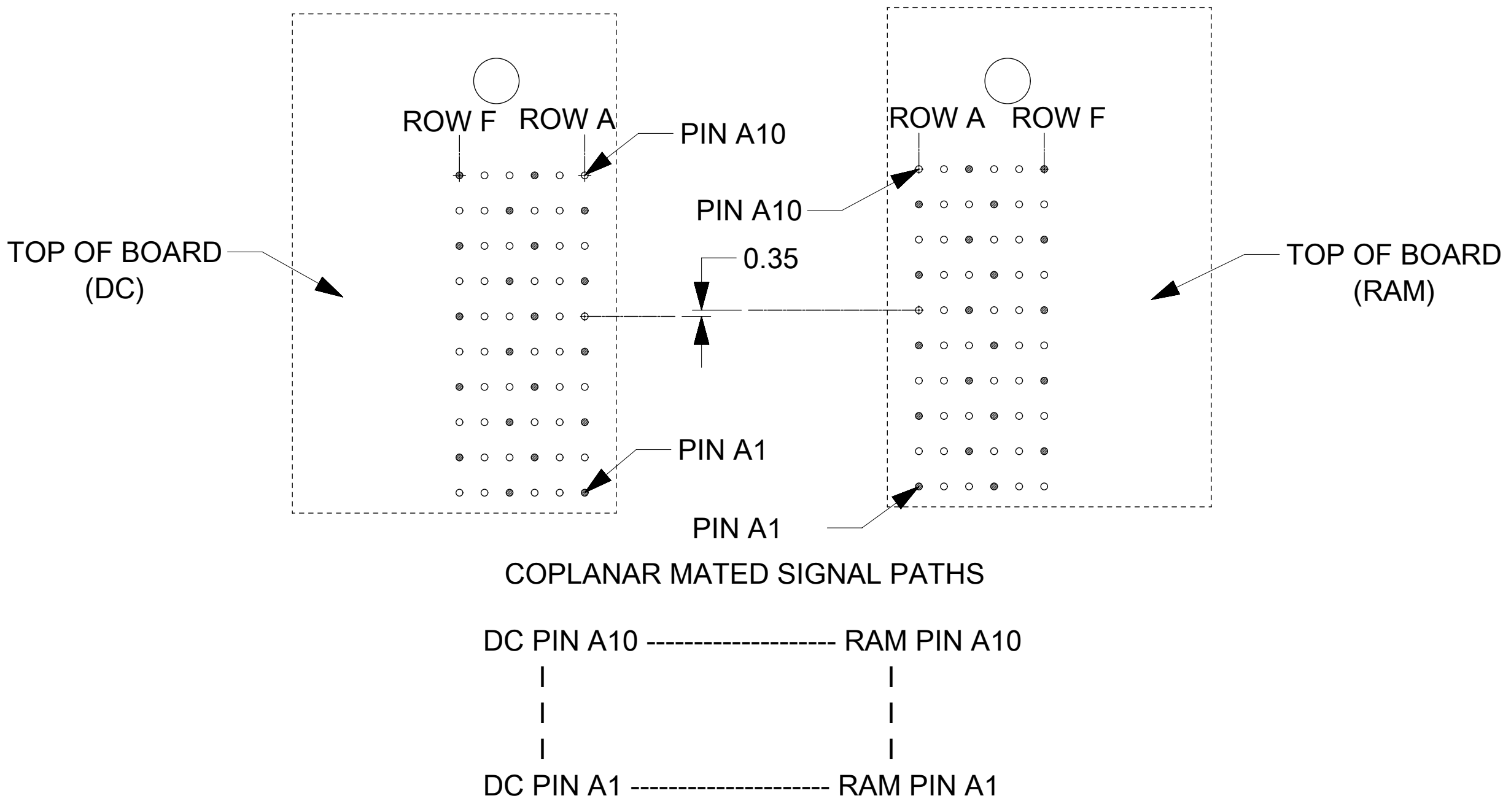
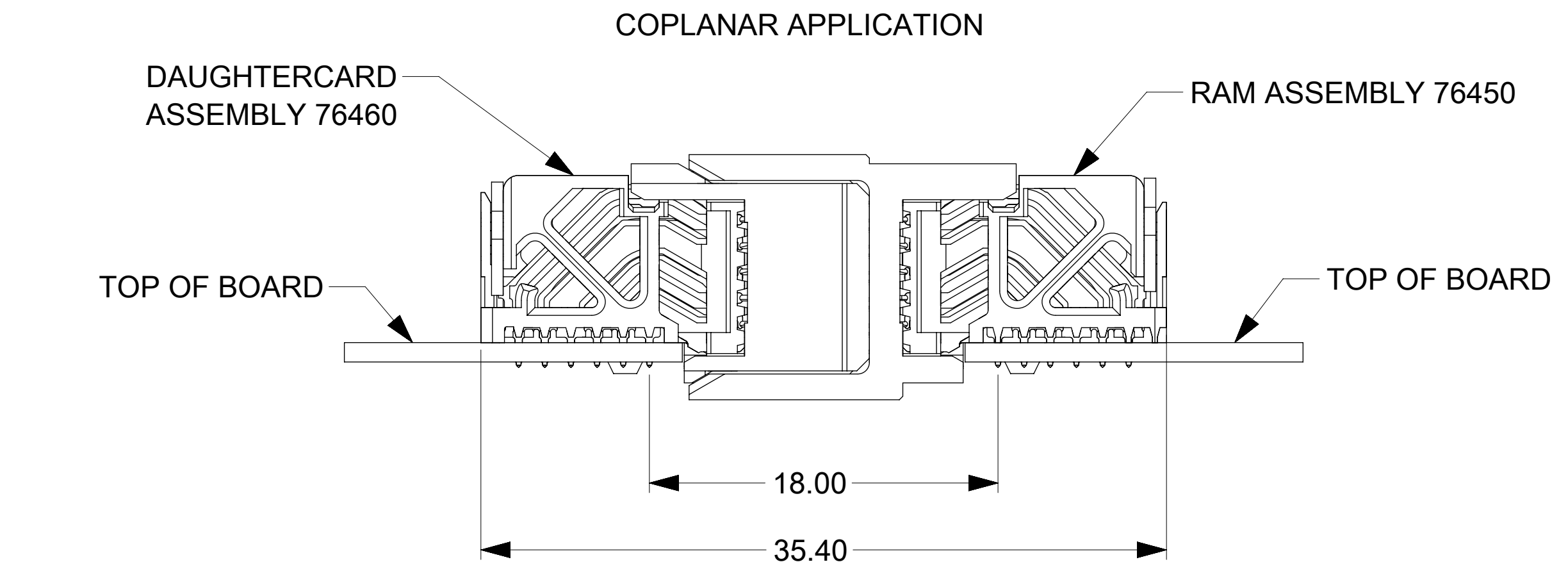


RAM HOLE PATTERN (CONNECTOR SIDE)
